3. Senator Bobbie Jo Champion update
 - Governors budget proposal - \$150 mil appropriation bonds to rebuild from the civil unrest. Over 700 mil and \$600 mil federal dollars for education and more.
 - \$35 mil in a law enforcement account to draw from to assist in preparing for the upcoming Chauvin trial
 - February 11th is a town hall meeting. 7:00 on Zoom
 - Vaccine distribution options are expanding to include pharmacies and clinics. North Point is taking persons not current patient but within the north Minneapolis zip codes.
